A notary's authentication is intended to be reliable, to avoid the inconvenience of having to locate a signer to have them personally verify their signature, as well as to document the execution of a document perhaps long after the lifetime of the signer and the notary. A notary can document that the notary administered an oath to an individual.

A notary may be held personally responsible for improper, negligent or fraudulent acts.
